From the President's Corner

A weed by any other name . . . is still a weed. And they seem to be everywhere! Whether you choose to cut, pull, or spray, dozens of landscaping companies—and even some young people off school for the summer months—would happily spruce up our yards for a reasonable fee. In my attempt to define what a weed is, I came up with this: if I did not plant it, and it is growing where I do not want it, it is probably a weed.

Many of our residents have birdbaths and feeders so they may enjoy the varieties of birds and other small wildlife in our area. Unfortunately, we have had reports of cats roaming the neighborhoods and killing birds and small rabbits. Small pets make easy targets for coyotes, javelinas, and bobcats that also roam our neighborhood. In consideration of our fellow neighbors, and for safety's sake, responsible pet owners should control roaming cats.

If stray cats enter your yard, residents can try several things that may keep cats away (Courtesy of the City of Chandler):

- Spray concentrated orange juice or hang orange or lemon peels in areas where cats are spraying. They are put off by the citrus scent.
- Similarly, some people advocate coffee grounds, blood meal, cayenne pepper, lavender oil, lemon grass oil, peppermint oil, eucalyptus oil, or citronella oil. (Don't use citronella-scented lamp or torch oil, as these are flammable.)
- Get a motion-detecting device that turns on a sprinkler or bright light in response to motion in your yard or garden.
- Squirt a hose at cats either when they come by or they squat. Just shock the cat; don't knock it over.
 Some people think a squirt gun works best.
- Many commercial cat repellants are available in garden stores, pet shops, and online. Read directions carefully, and be sure to wear gloves for chemical sprays.
- Some non-chemical repellants emit an ultrasonic electric pulse that many cats find annoying.

President's Update:

The Cliff Rose Board of Directors has entered into an agreement with HOAMCO to handle compliance for our community. With nearly 400 homes built, our sevenmember Board feels that we are unable to adequately perform all the necessary functions. More information will be available at our Annual Meeting on September 24.

Here are a few facts:

- This is a month-to-month agreement with a thirty-day cancellation policy.
- We will have bi-weekly (every other week) inspections by a compliance officer.
- If rules violations are noted, HOAMCO will be responsible for mailing letters to homeowners advising them of the violation and a time frame to correct the non-compliance.
- In addition, we are expanding our Board from seven to nine members. The two new directors will be dedicated compliance positions.

We are hopeful that we will need HOAMCO only on a temporary basis. If you have concerns or questions, please email

Political Signs

This election year the primary election takes place on August 30, and the general election is November 8. Because of the closeness of these elections, our rules allow for political signs from now until ten days after the general election. Please remember that total sign area permitted on any lot cannot exceed thirty-two square feet, and kindly remove your signs promptly after the election. Thanks for your cooperation.

Rules & Regulations 3.1.5. **Political Signs:** The display of political signs shall be limited to a period of seventy-one (71) days before the day of an election for which the signs pertain. (A.R.S. 33-1808) The total sign area permitted on any lot cannot exceed thirty-two (32) square feet. The signs may be free standing. Signs shall be removed within ten (10) days after the primary, general or special election. (See the Prescott City Zoning Code, Section 6/12, F, 4.)

Light Pollution

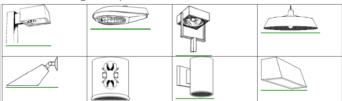
Recently, a well-known, active Cliff Rose resident wrote to say since nice weather is here, many people enjoy sitting out in the cool air to view the evening sky, but more outside lights are being left on and are obscuring the stars. The writer also said, "I thought Arizona had a night sky ordinance and our homeowners CC&Rs have a bulb brightness and covering regulation."

After doing a little research on this matter, I found that our contributor is on the mark. Yavapai County does, indeed, have a Dark Sky Ordinance (section 603) that can be viewed in its entirety at www.yavapai.us.

On Wednesday, September 2, 2015, Yavapai County Land Use and Planning Manager, Dave Williams, wrote an

article in the *Verde Independent* newspaper. He said that when "Inspectors examine lighting on properties, they ask themselves a few simple questions to determine whether or not the lighting is compliant." These questions include

"Is the light bulb visible?" That means that the **BULB** cannot be seen when looking at the fixture from above or when viewed directly from the side. The ordinance shows these as being acceptable outside fixtures:



The lights below are not considered as acceptable under county law:



"How is the light aimed? If the light is aimed downward to keep all of the light on an owner's property, then the light fixture is most likely compliant." If the light spills onto an adjacent property, this is a violation entitled light trespass.

"How many lights . . . are on a property?" The total should not exceed 20,000 lumens. For energy star bulbs, 40 watts equals approximately 450 lumens, and a 60 watt bulb equals 800 lumens. HOA rules state that outdoor bulbs must be 25 watt frosted bulbs or 4 watt fluorescent maximum for front yards or for pole lighting. Anything over that must be on a motion sensor.
